IN RE: COURT OPERATIONS DURING THE COVID-19 PANDEMIC.

ADMINISTRATIVE ORDER NO. 2020-8

This Administrative Order is being issued in response to the continued outbreak of the Coronavirus Disease 2019 (COVID-19) in the Western District of Arkansas. Considering the severity of risk posed to the public, court staff, and other court agencies, this Order extends the moratorium on in court proceedings previously entered in Administrative Order No. 2020-1, Administrative Order No. 2020-4 and Administrative Order No. 2020-5. Accordingly, the following order will be implemented within all divisions in the Western District of Arkansas:

1) All civil and criminal trials (bench and jury) currently scheduled to begin before August 3, 2020 are continued pending further order of the Court. The postponement of these cases will be assessed by the Court in mid to late July to determine whether further postponement is appropriate.

2) As to criminal trials, the time between the date of this administrative order and the new trial date shall be excluded from consideration of the Speedy Trial Act pursuant to 18 U.S.C. § 3161(h)(7)(A), as the Court specifically finds that the ends of justice served by ordering these continuances outweigh the best interests of the public and any defendant's right to a speedy trial.

3) All grand jury proceedings are continued until July 28, 2020. Due to the unavailability of the grand jury, the 30-day time period for filing an indictment or an information is tolled as to any defendant during the time period of the continuances occasioned by Administrative Order No. 2020-1, Administrative Order No. 2020-4, Administrative Order No. 2020-5 and this Administrative Order, pursuant to 18 U.S.C, § 3161(b).

4) As to the grand jury, the Court also finds that the ends of justice served by ordering this continuance outweigh the best interest of the public and any defendant's right to a speedy trial. Therefore, the time period of the continuance occasioned by Administrative Order No. 2020-1, Administrative Order No. 2020-4, Administrative Order No. 2020-5 and this Administrative Order is excluded from consideration of the Speedy Trial Act pursuant to 18 U.S.C. § 3161(h)(7)(A), and will not be considered in determining if an Indictment or Information is filed within the time limits set forth in 18 U.S.C. § 3161(b).

4) All petty offense (CVB) proceedings are continued until August 3, 2020.

4) The naturalization ceremony scheduled for July 31, 2020, in Fayetteville, Arkansas is cancelled and will be rescheduled at a later date.

5) Unless amended by this Order, all other provisions of Administrative Order No. 2020-1, Administrative Order No. 2020-4, Administrative Order No. 2020-5 and Administrative Order No. 2020-7 remain in effect.

This Order remains in effect until further order of the Court.
